

**CANBY CITY COUNCIL  
REGULAR MEETING MINUTES  
November 1, 2017**

Hometown Hero Presentation – Mayor Hodson spoke about the Hometown Hero Award and the criteria for receiving the award.

Councilor Heidt read a letter she had submitted which nominated Walt Daniels for the award.

Julie Wehling, Transit Director, spoke about Mr. Daniels' contributions to the Transit Advisory Committee on which he was serving and Canby Area Transit.

Rich Ares, Canby resident, discussed how Mr. Daniels' service had benefitted the City's parks and the community.

Dan Murphy, Canby Utility General Manager, stated Mr. Daniels was currently serving on the Canby Utility Board. No one had more historical knowledge than Mr. Daniels and he appreciated his leadership.

Luana Hill, Canby resident, discussed Mr. Daniels' work with Kiwanis. He had been a recipient of the Hixon Award. She spoke about projects that Kiwanis was working on.

Mayor Hodson read nomination letters from Richard Ares, John Dragt, and Don Smeback which had accompanied Councilor Heidt's nomination letter. He then read the Hometown Hero certificate.

Councilor Heidt presented Mr. Daniels with the certificate.

Mayor Hodson presented the plaque that was displayed at City Hall with Mr. Daniels' name.

Mr. Daniels thanked everyone for the award. He encouraged everyone to use their talents and skills and give back to the community.

**RESOLUTIONS & ORDINANCES:** Resolution 1273 – Amanda Zeiber, Assistant City Administrator/HR Director, said the City and union met over a series of several months to negotiate the AFSCME union contract that would be effective July 1, 2017 to June 30, 2020. They had come to an agreement and the contract was before Council for approval. There was one minor change which had to do with the renumbering of the articles in the contract. The biggest change was the health care provider and slightly different health care plan that would be phased in over the three years of the contract.

Councilor Parker said they had several previous meetings where the negotiations had been discussed.

Motion was seconded by Councilor Hensley and passed 6-0.**
