

## RESOLUTION NO. URR 13-003

### **A RESOLUTION DECLARING THE CANBY URBAN RENEWAL AGENCY'S INTENT TO AWARD THE BID AND SIGN A CONTRACT WITH NORTH SANTIAM PAVING COMPANY FOR THE CONSTRUCTION OF SEQUOIA PARKWAY STAGE 7 STREET IMPROVEMENTS & OREGON PACIFIC RAILROAD CROSSING**

**WHEREAS**, the Canby City Council established the Canby Urban Renewal Agency ("Agency") as an urban renewal agency to function within the City pursuant to Ordinance 1032 passed October 6, 1999; and

**WHEREAS**, the Agency has been directed to undertake the extension of Sequoia Parkway to SE 13th Avenue including a grade separated crossing of the Oregon Pacific Railroad, herein referred to as Sequoia Parkway Stage 7; and

**WHEREAS**, the Agency issued an Invitation for Bids on March 11, 2013 in the Daily Journal of Commerce, soliciting the services of a General Contractor to construct the Sequoia Parkway Stage 7 improvements; and

**WHEREAS**, sealed bids were submitted by fourteen Bidders and publically opened and read aloud on April 2, 2013; and

**WHEREAS**, bids were tabulated and reviewed for responsiveness and Bidder responsibility, and all bids were found to be responsive; and

**WHEREAS**, a summary of the bids received is attached herein as Exhibit "A"; and North Santiam Paving Company was identified as the low responsive, responsible bidder with a total bid of \$3,262,681.20; and

**WHEREAS**, a Notice of Intent to Award the construction contract was issued on April 3, 2013 and sent to all bidders; and

**WHEREAS**, no protests of the award were delivered to the Public Contracting Agency as of the hour stated for the award.

**NOW THEREFORE, IT IS HEREBY RESOLVED** by the Canby Urban Renewal Agency as follows:

1. The Agency hereby Awards the construction contract for Sequoia Parkway Stage 7 to North Santiam Paving Company in the amount of \$3,262,681.20; and
2. The Agency hereby authorizes the Agency Director to execute on behalf of the Canby Urban Renewal Agency, the contract which is attached as Exhibit "B" to this resolution;

This Resolution shall take effect on April 10, 2013.


