City of Canby enacts the following ordinance governing the Canby Logging Road Multi-use Path to be used alongside Oregon Parks Regulations per Canby Ordinance 914.

Canby Logging Road Multiuser Path Ordinance:

- Speed limit - 15 MPH

- Oregon House Bill 4103 allows for persons to be fined \$100 for unsafe e-bike riding. The offense of unsafe electric assisted bicycle riding is a Class E traffic violation. Repeat offenders may be banned from the Canby Logging Road Multi-use Path.

- Allowed are Class 1 and Class 2 E bikes. Minimum age of e-bike rider is 16 for Class 2 but children under 16 may ride Class 1.

- Class 3 e-bikes and electric bikes/cycles with motors exceeding 1,000 watts are prohibited.

- This ordinance allows persons with disabilities to operate a motorized wheelchair.

- Segways, hoverboards and scooters.

Are allowable. I believe the 15 mph speed limit should cover inappropriate behavior and can go unmentioned. Consider deleting this paragraph.

- Motor vehicles, motorcycles, cars and trucks are prohibited with the exclusion of Canby Public Works, Police, Fire vehicles and Ambulances. The Canby Logging Road Multiuser Path is also an emergency access road to be used by City of Canby.
- Canby Public Works and Canby Police shall collaborate on safety issues. Canby Public Works may post signs to educate and enforce this ordinance.
