Hey Erik,

I've reviewed the updated plat and do not have any concerns related to the new local street. It's an indirect route, and does not create the potential for a significant increase in through trips along that route, outside of perhaps the 2 or 3 new lots with frontage on "Road A". The rest of those lots along it already had access to the north. The TIS evaluated the neighborhood impact to the north, and previously projected no more than 19 peak trips. Even if the 3 new lots take that route now, the neighborhood trip "impact" threshold will not be triggered, and volumes will still be within the range of a typical local street.

Hope this helps and let me know if you have any other questions.
