Good afternoon DC English, As the new Chairperson of Canby Traffic Safety Commission I am writing today to get your input on “Speed Cushions” potentially on Canby streets. This letter is being addressed to you as you are listed as the Liaison to the Canby Traffic Safety Commission, Officer Allen Miller the Liaison from the Canby Police Department wanted me to express to you of his regularly attendance and input to the Canby Traffic Safety Commission and looks forward to seeing you at the meetings as Commission does also, I have heard about the Departments disapproval of Speed Bumps in the past, and we still recognize that input to the Commission.

We on the Commission are being asked for speed bumps to “slow traffic or speeders”. We evaluate all options we currently have depending on circumstances, but there will come a time with Canby growth we will need a larger pool of options at hand if that time is not upon us currently. I hope to get not only input from you but also from the Chief’s down to the front-line medics as your concerns and input from just this one of many videos <https://www.youtube.com/watch?v=8ymIskUCri4> will be very important for the City of Canby. Also, at this time I am seeking additional information pertaining especially to your ambulance’s wheel width dimensions and then any other emergency vehicle that might be concerned similar in those dimensions. This information will be used by the Traffic Safety Commission to refer to during our evaluation stage. Most importantly I hope to start and continue an ongoing discussion and potentially a workable solution for the citizens, the Fire Dept. and the Traffic Safety Commission.

I end by saying thank you for your time and due diligence regarding this as we on the Commission hope to have something in writing and available for your presentation to the Traffic Safety Commission meeting on June 12th, 2024.
